WHAT: Demonstration commemorating "Operation Blue Star," the **Golden Temple massacre of 1984**, as well as to protest against **Prime Minister Narendra Modi's** oppressive government. [Sikhs for Justice](#) is demanding self-determination.

WHEN: Thursday, June 6, 2019, 5 p.m. - 7 p.m.

WHERE: The Lincoln Memorial, Washington, DC

WHY:

- **Marking** the 35th year of Indian Army's attack "Operation Blue Star" against the Golden Temple in June 1984 and Condemning attack on the holiest Sikh shrine and massacre of the Sikh pilgrims.
- **Re-affirming** Sikhs right of self-determination under UN Conventions and International Law.

- **Highlighting** democratic initiative of holding first ever unofficial Referendum 2020 www.referendum2020.org among the global Sikh community on the question of secession of Punjab from India, under the principle of the right of self-determination for all peoples.



Sikhs for Justice is a human rights advocacy group. SFJ believes in Universal Declaration of Human Rights and endeavors to create an environment in which minorities - regardless of race, religion, language, gender, or ethnicity - can freely exercise their right to “self-determination” as enshrined in the Universal Declaration of Human Rights and United Nations Covenant on Civil and Political Rights. SFJ is working to seek justice (through legal political and judicial means) for the Sikh population of India through spreading awareness on an international level, especially about November 1984 Genocide of Sikhs in which more than 30,000 Sikhs were targeted and killed throughout India in a span of 4 days, from Nov 01 to 04.
